UMA TACHOMETER FOR
4 cylinders or 6 cylinders SLICK MAGNETO

Installation Instructions:

Additional wire and fuses may be necessary for installation of unit.

- 1) Tachometer is factory calibrated for 6 cylinders engines. If you are connecting tachometer to an engine with 4 cylinders, you must cut the violet wire loop at back of tachometer.
Mount instrument in aircraft's instrument panel.
Connect white wire (tachometer input) of tachometer to the P-Lead of one magneto. Connection can be made at magneto switch terminals. Make sure to connect a fuse or breaker (Use 1/4 amp) inline between the magneto switch and the tachometer.
For tachometer RPM reading during Left and Right magneto checks, you can install a SPDT switch (either toggle or rocker panel) between magneto switch and tachometer input (white wire). Connect the common terminal of switch to white wire of tachometer. Connect one terminal of Tachometer Selector Switch to left magneto connection on magneto switch. Connect the other terminal of Tachometer Selector Switch to right magneto connection on magneto switch. Refer to Figure One.
Next, connect the Red wire from tachometer to power source of plane. (Use an inline 1 amp fuse or breaker) Then, connect the Black wire to common ground of engine.

Note: Route wires away from hot surfaces and moving parts using wire ties as needed.

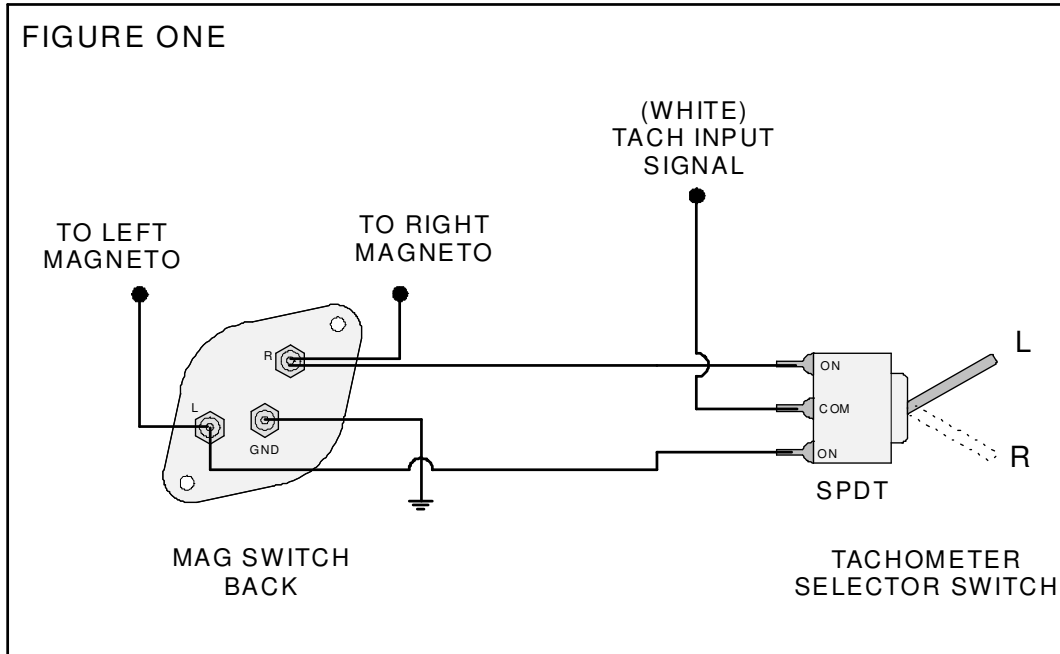
Fuse (Power):	1 Amp Fast Acting	
Fuse (Tach input):	1/4 Amp Slow Blow	
Current Draw (typical):		
Pivot & Jewel Type:	2 1/4" = 50 mA	3 1/8" = 70 mA
Aircore Type:	2 1/4" = 90 mA	3 1/8" = 90 mA
Supply Voltage:	+14 to +28 Volts D.C.
